## NOTICE FOR THE NATIONAL GAZETTE

- I, **Jelta Wong**, Minister for Health and HIV/AIDS, by virtue of the powers conferred by Section 11 of the *Quarantine Act* 1953 and Section 15 of the *Public Health Act* 1973 and all other enabling powers, hereby make the following declaration:
  - The novel coronavirus COVID-19 is declared to be a quarantinable disease under the Quarantine Act 1953 and an infectious disease under the Public Health Act 1973; and
  - For the avoidance of doubt, I revoke a previous declaration that the novel coronavirus reported on 31st December, 2019 in Wuhan City, Hubei Province of China is quarantinable disease under the Quarantine Act 1953 and an infectious disease under the Public Health Act 1973

## NOTICE FOR THE NATIONAL GAZETTE

I, Jelta Wong, Minister for Health and HIV/AIDS, by virtue of powers in Sections 4(1) 5(1), 13(1)(a) and 15 of the Quarantine Act 1953 and all other enabling powers, I declare that:

#### Notice for the National Gazette-continued

- I am satisfied that an epidemic caused by a quarantinable disease being COVID-19 or danger of such an
  epidemic exists in Papua New Guinea.
- An emergency in relation to the global spread of COVID-19 has arisen that requires action to be taken not
  otherwise authorized by the Quarantine Act 1953.
- The measures incidental to quaranatine, I think necessarry or desirable for the diagnosis, prevention and treatment of a quarantinable disease being COVID-19 and whose implementation I immediately order on commencement of this Notice are that:
  - a. a port of entry stated in Column One of Table One in Schedule One is:
    - i. a first port of entry for aircraft or vessels as stated in Column Two for the time period stated in Column Three of Table One; and
    - a temporary quarantine station, for the period in Column Two for the performance of quarantine by any vessel, person, animal, plant or goods; and
    - iii. designated as a Point of Entry for the purposes of Article 20(1) of the International Health Regulations (2005);
  - no vessel or aircraft may have entry at a port of entry in Papua New Guinea which is not a declared
    a first port of entry under Section 12(a) of the Quarantine Act 1953;
  - c. no person or persons may cause a vessel or aircraft to arrive at a port of entry in Papua New Guinea which is not a declared a first port of entry under Section 12(a) of the *Quarantine Act* 1953;
  - d. no vessel which is a large ship or yacht that has 15 or more persons on board, that carries people on voyages for pleasure, typically calling in at several places may have entry to any port of entry in Papua New Guinea for 60 days from the date of commencement of this Notice; and
  - e. no person or persons may cause a vessel which is a large ship or yacht that has 15 or more persons on board, that carries people on voyages for pleasure, typically calling in at several places may have entry to any port of entry in Papua New Guinea for 60 days from the date of commencement of this Notice.
- The place stated in Column One of Table Two in Schedule One is a temporary quarantine station for the
  performance of quarantine by any person for the time period stated in Column Two of Table Two.
- For the avoidance of doubt, by this Notice, I revoke all previous National Gazette Notices declaring any temporary quarantine stations.

This Notice comes into force on the day of its gazettal.

# DECLARARTION OF THE MINISTER FOR HEALTH AND HIV/AIDS

## NOTICE FOR THE NATIONAL GAZETTE

- I. Jelta Wong, Minister for Health and HIV/AIDS, by virtue of powers in Sections 4(1) 5(1) and 12(a) of the Quarantine Act 1953 and all other enabling powers, I declare that:
  - 1. I am satisfied that an epidemic caused by a quarantinable disease being COVID-19 or danger of such an epidemic exists in Papua New Guinea; and
  - 2. an emergency in relation to the global spread of COVID-19 has arisen that requires action to be taken not otherwise authorized by the *Quarantine Act* 1953; and
  - the following countries and regions are proclaimed places under Section 12(a) of the Quarantine Act
     1953 and are infected with a quarantinable disease being COVID-19:
    - (a) Peoples Republic of China (only including Mainland China);
    - (b) Republic of Korea (South Korea);
    - (c) Islamic Republic of Iran;
    - (d) The European Union:
    - (e) The United Kindom; and
    - (f) The United States of America.

## Notice for the National Gazette-continued

- 4. the measures incidental to quarantine, I think necessary or desirable for the diagnosis, prevention and treatment of a quarantinable disease being COVID-19 and whose implementation I immediately order on commencement of this Notice are that:
  - (a) no person is permitted to board an aircraft or ship bound for Papua New Guinea from any foreign point of depature or airport if that person has been in a proclaimed place or transited through a proclaimed place in the past 14 days prior to the day the vessel or aircraft departs on its journey to PNG; and
  - (b) persons boarding military aircraft or ships are exempt from this declaration.

The Notice comes into force on the day of its gazettal and continues in force for 90 days.
